By accessing our applications and services through any Platform and completing and/or purchasing a Service in which we explicitly provide, you acknowledge and agree to have read, understood, and agreed to the Terms and Conditions set below.

The following pages, along with any content and subset of the pages, and the online forecast Service provided by Rain or Shine Weddings are provided for your personal, non-commercial use only, subject to the Terms and Conditions set out below.

0. Definitions

“Rainorshineweddings.com,” “us,” “we,” or “our” means Rain or Shine Weddings.

“Platform” means website or mobile application on which the service is made available, owned, managed, maintained, and/or controlled by Rain or Shine Weddings.

“Service” means the weather/meteorology forecasting services, along with any and all other services and requests as made available from time to time by Rain or Shine Weddings.

“Request” means to the location, time of year, specific date, or any request the Purchaser and Rain or Shine Weddings agree upon at the time of purchase.

“Purchaser” is defined as the name on the credit or debit card listed on the confirmation email and/or any additional people associated with listed card name in communication with us.

1. Scope of Services

Through the Platform, we provide an online forecasting Service to provide purchasers with weather information for a Request.

By purchasing a Service, you enter a direct, contractual relationship with Rain or Shine Weddings. From the point purchase, you will directly work with us to facilitate the Request. No third party will be discussed or taken into consideration nor is any third party eligible to receive payment.

We do not recommend, advise, or suggest what actions to be taken with delivered weather/meteorology information. We do not assume any responsibility (expenses incurred and/or damage) for the actions of the Purchaser after the Service has been delivered.

2. Pricing

The prices listed on the Platform are subject to change. Should the Service price increase, the Purchaser will not be billed for the increased rate. Should the Service price decrease since the time of original purchase, the Purchaser is not entitled to the difference.

3. Notice of Purchase

Any and all Services must be purchased (30) days prior to Request.

Any Service that is purchased within (30) days of Request will be subject to additional charge outlined on Platform.

4. Refund Policy

The Purchaser is entitled to a complete and full refund of Service charge if we are notified within (24) hours of the purchase. The refunded amount will take 3-5 business days to be returned to the Purchaser.

After the (24) hour refund period, the full payment of purchased Service will be received by Rain or Shine Weddings. The Purchaser knowingly and willingly accepts that there will be no refund due to any weather conditions that have or have not been discussed through the Rain or Shine Wedding process.

All special offers and promotions are marked as such.

5. Disclaimer

Subject to the aforementioned terms and conditions, Rain or Shine Weddings is not liable for direct damages suffered, paid or incurred by you due to an attributable shortcoming of our obligations in respect to Service Request. We are not responsible for any action taken, action paid for, or additional expense that was not set out in the confirmation email. The Purchaser assumes all responsibility for cost associated with any and all weather-related loss or damage of goods, loss of profit, loss of revenue, loss of contract, loss of claim.
